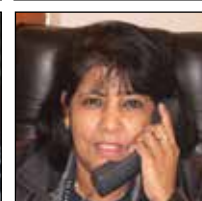

MESSAGE FROM THE CHAIRPERSON



South Africa has, on paper, one of the most enabling legal environments for non-profit organisations. The sector, however, currently finds itself increasingly under threat as donor funding continues to dwindle and financial survival looks bleak. Despite enduring crippling fiscal challenges itself this past year, NICRO nevertheless successfully weathered the storms, maintained service delivery and made significant progress in terms of entrenching its sustainability plan. I am immensely proud to be at the helm of an enduring organisation that is widely acknowledged as a leader in the field and a principal provider of cutting edge, effective and truly impactful crime prevention and offender reintegration services.

As a pioneer of youth diversion services and an organisation which boasts a rich, unparalleled history in juvenile justice, NICRO is deeply concerned that crimes committed by child offenders are increasingly becoming more violent and occurring at an earlier age and that young people, particularly young men, constitute both the majority of perpetrators and victims of violence and crime in our country.

This publication highlights and celebrates NICRO's fine accomplishments this past year. Despite many challenges and difficult financial decisions, given that the organisation started the year with a debilitating accumulated deficit of R9 million and a severe cash flow crisis, NICRO concluded this financial year on a high note and in true celebratory fashion.

I am extremely proud to report that we succeeded in settling our debt and, for the first time in many years, in reaching our funding target. NICRO has no major liabilities at this time, providing us with a wonderful opportunity of creating wealth.

During the last financial year, we budgeted in a manner very different from the norm. We reflected only donation income which had already been secured or had at least a 95% chance of being realised. As a result, our deficit has been all but cleared and we plan on breaking even in the coming financial year.

Not only did NICRO manage its crippling cash flow and financial challenges strategically; we were able to continue the delivery of quality services and maintain the status quo of our projects at community level. Above all, NICRO resolutely continued to focus on its primary goal of achieving sustainability, making steady progress in this regard also. The overview of services and provincial reports bear testimony to the remarkable work of an organisation that continued to make a remarkable difference in the lives of its beneficiaries and which achieved its service delivery targets despite serious resource challenges.

I, once again, pay tribute to our Chairperson, the Honourable Justice Nathan Erasmus, and our Board of Directors for their support and guidance. Special thanks to NICRO's staff and volunteers who, despite the many challenges, continue to serve our beneficiaries with unwavering passion and commitment. We acknowledge, with gratitude, the Department of Social Development and aware.org, without whose financial support NICRO would not have achieved its objectives this last year. We are also deeply grateful to the National Lottery Commission for its ongoing support over many years. To all our donors and supporters, we salute and thank you!

OVERVIEW OF SERVICES

NICRO's legacy these past twelve months has at its foundation concerted efforts to entrench crime prevention initiatives, maintain good working relationships with communities and authorities, capacity building initiatives for community-based organisations and other stakeholders and our continued commitment to the provision of quality services and interventions. The significance of the achievements which we celebrate at this time, despite serious financial constraints and limited resources, is a testament to the unfailing commitment on the part of our staff to NICRO's beneficiaries and to the passion with which we strive to achieve our vision and mission.

Provincial Service Delivery

NICRO's services are rendered from 16 offices and 47 service points located within communities and / or at courts throughout the country, with the exception of the North West.

During the year under review, NICRO rendered 24 955 individual and group-based interventions to beneficiaries, many of whom were in receipt of more than one service. Additionally, 107 386 beneficiaries were reached through a wide range of provincial community awareness initiatives, focussed primarily on crime prevention.

NICRO succeeded in touching the lives of many more people this last year. Beneficiaries of adult diversion interventions effectively doubled in the course of 2017/18. Youth diversion, similarly, saw a significant increase of 62.8% in beneficiaries reached: 3 778 this financial year in comparison to 2 321 beneficiaries in 2016/2017. Offender reintegration and non-custodial sentencing services increased by 19%. NICRO is equally pleased to report that, in overall terms, a service delivery attainment of 139.9% was realised. These are remarkable achievements in the light of challenges experienced throughout the organisation.

- NICRO successfully diverted 3 778 children and youths in addition to 18 928 adults who had committed crime and were in conflict with the law. These beneficiaries successfully avoided incarceration and receiving a criminal record. Participation in a NICRO diversion programme reduces risk factors associated with criminal and delinquent behaviour, promotes favourable attitudes and develops critical skills that equip former offenders to successfully steer away from further involvement in crime.
- During this time NICRO also rendered offender reintegration services to 1 207 offenders of whom 590 were adults who were given non-custodial sentences and 617 who had been released from prison.
- The Safety Ambassadors Programme, a schools-based crime prevention initiative incorporating a focussed behaviour change element, worked with 452 Safety Ambassadors while reaching an additional 10 396 learners nationwide.

Current Trends

NICRO remains the primary provider of adult diversion services in the country, which continues to be NICRO's largest service on offer. This is as a result of NICRO's remarkable track record and evidence-based practice, as well as extensive lobbying for the diversion of adults who have committed non-violent, less serious petty crimes.

Enabling offenders to remain employed or secure re-employment while providing for their families is an important factor in encouraging such persons not to re-offend. It provides them with the socio-economic wherewithal to take responsibility for their actions and make amends for their misconduct. They are simultaneously afforded access to significant life skills development, personal empowerment opportunities and support services, in addition to a real chance at turning their lives around and steering clear of further criminal activities.

Although the increase in youth development services is indicative of improved stakeholder collaboration on the one hand, it is also as a result of the growing

challenges experienced by South African youth. We have therefore steadily increased our youth crime prevention work in schools because of the high levels of crime and violence encountered in educational institutions.

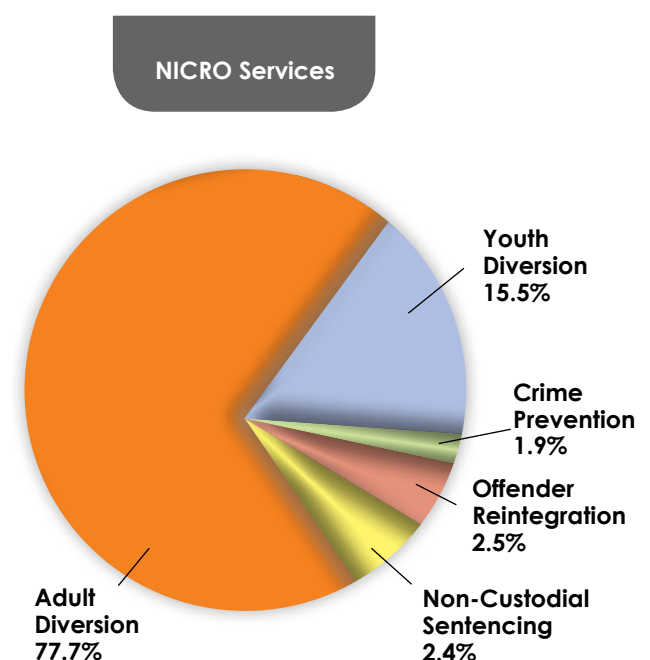

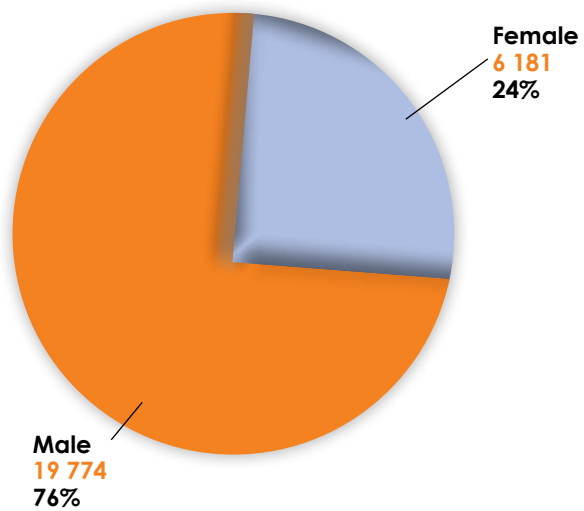
Services by Province: An Overview

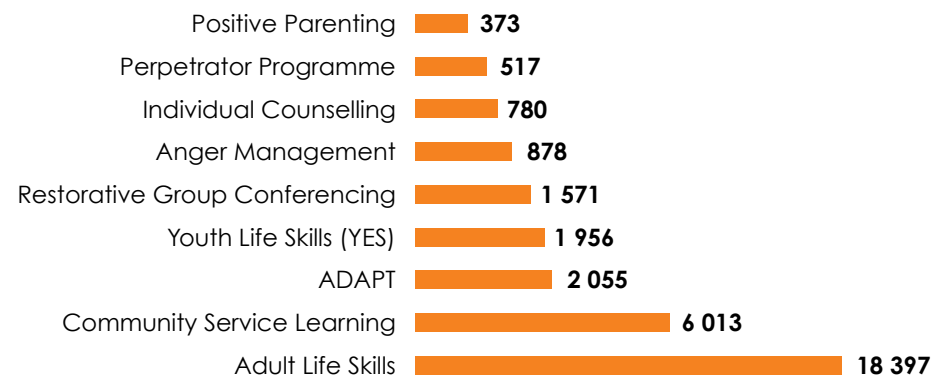

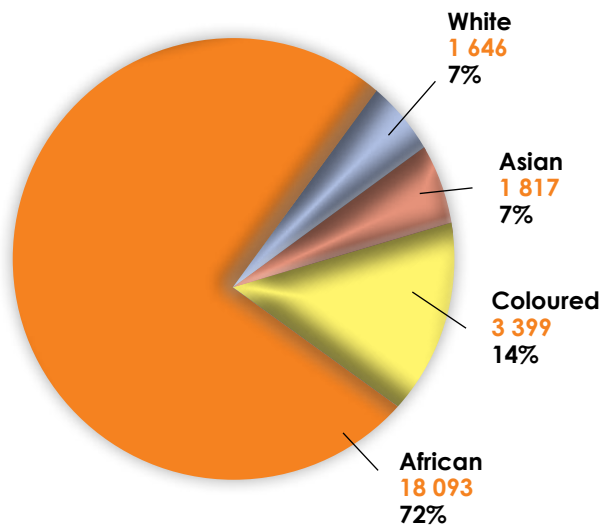
Gender Profile



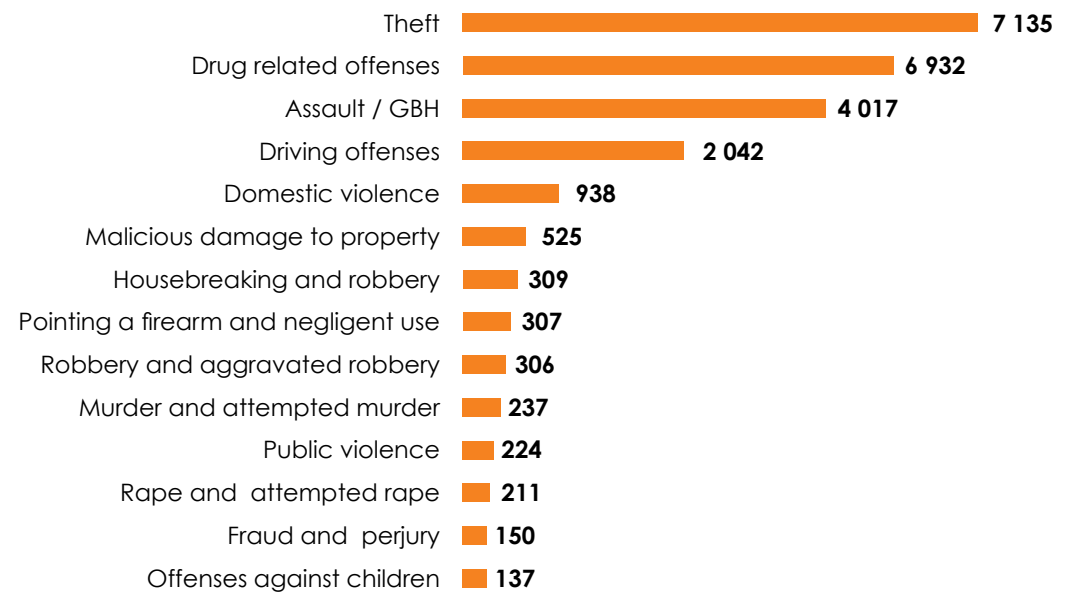
Number of Beneficiaries by Intervention



Racial Profile



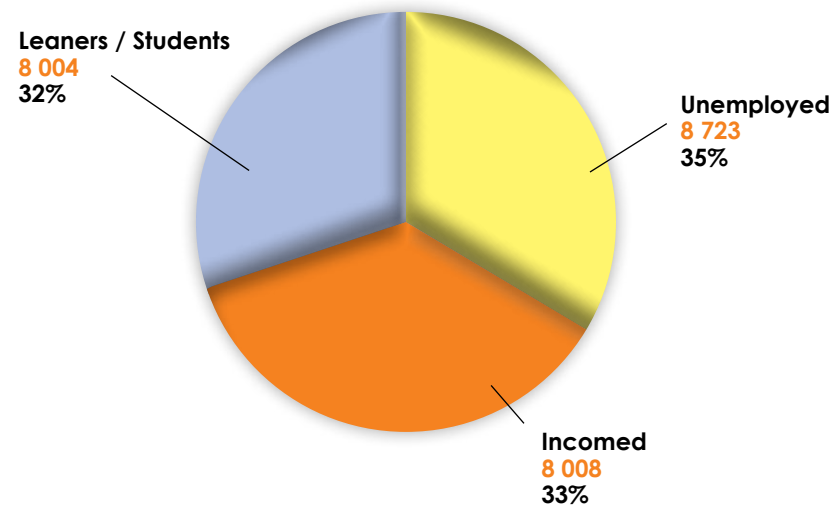
Nature of Offences Committed by NICRO Beneficiaries



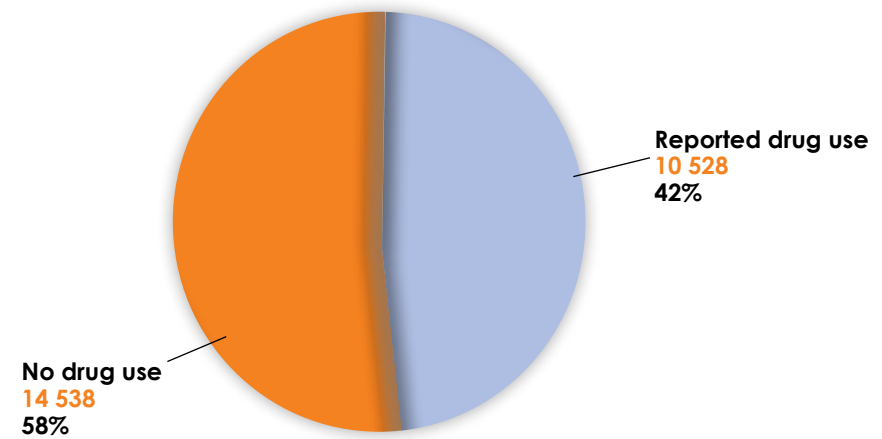

Beneficiary Self-Reported Drug Use

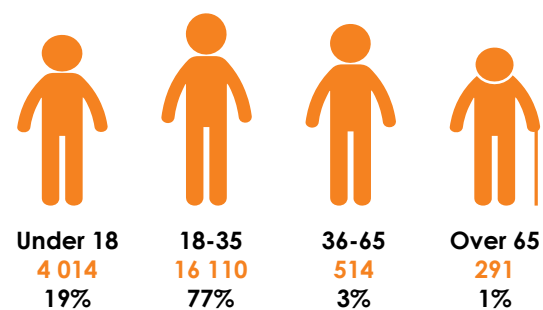

ADVOCACY AND LOBBYING

*We need leaders not in love with money but in love with justice.

South Africa continues to face high levels of crime and violence that are complex in origin. Finding ways to reduce crime and prevent violence remains critical. Epigenetics, exposure to violence, past oppression, poverty and inequality, high unemployment rates and broken families are just a few of the root causes which need to be addressed through earlier intervention. NICRO believes that imprisonment should be a last resort and is in support of the global fight against mass incarceration. NICRO is currently experiencing challenges with the courts which tend to enforce harsh sentencing laws. Far too many people who could benefit from alternatives are sentenced to imprisonment. These include offenders who are found to have drugs in their possession and those who cannot afford bail.

Effective reintegration efforts also serve to prevent crime. There are opportunities to prevent and reduce crime by rebuilding social cohesion and families as well as ensuring adequate child protection services. Communities need to be empowered with communication and conflict resolution skills so that they are better equipped to solve problems and deal with conflict before this ends up at the doorstep of an already overburdened criminal justice system.

Advocacy and lobbying to improve laws and policies continue to form an important component of NICRO's work. Key focus areas this past year included:

- i. Unjust, rigid criminal record policies in South Africa that continue to prevent former inmates from securing employment to support themselves and their families,
- ii. Incarceration as a last resort and the use of alternatives to incarceration such as diversion and community-based sentencing for those with drug use offences and other relevant offences,
- iii. Early intervention at family, school and community level and preventing crime before it happens,
- iv. Adopting restorative justice as a dominant criminal justice model, and
- v. Prison reform and the rights of inmates in prison, with a particular focus on foreign inmates with expired refugee papers who do not qualify for parole and improving independent oversight in collaboration with the Detention Justice Forum (DJF).

Highlights

- A presentation on the use of restorative justice in cases of sexual offences and domestic violence conducted at the AIDS Foundation of South Africa and NACOSA national conference in Johannesburg in October 2017 to promote linking, learning and action on the state response to gender-based violence (GBV), the interaction between HIV and GBV and the impact of GBV on young people.
- Attendance of a two-day dialogue on the criminal justice system's response to sexual offences, hosted by the Deputy Minister of Justice and Constitutional Development.
- The presentation of a paper, Existing Alternatives to Incarceration in Africa and Globally, at The Global Prison: International Conference on Incarceration and Social Justice at the University of Johannesburg's Centre for Social Change in November 2017.
- Participation in the second African Regional Conference on Crime and Violence Prevention hosted by the African Policing Civilian Oversight Forum (APCOF).

- Co-hosting of a seminar on the Prison-to-College Pipeline (P2CP) initiative with offender reintegration role players. P2CP is an innovative educational programme developed in the US that provides prisoners with access to university-level education, mentorship and community support to increase their chances of timely graduation and employment upon release.

Looking Ahead

NICRO's lobbying and advocacy initiatives during the course of the next twelve months:

- Conduct research and gather case study material to improve lobbying efforts focussing on unjust criminal record policies in South Africa,
- Advocate for a Restorative Justice National Policy Framework which calls for diversion, non-custodial sanctions and alternative dispute resolution processes as a criminal justice model,
- Lobby for a law review that supports incarceration as a last resort and that all community-based intervention options are explored as an alternative to prison, and
- Support efforts to adopt and implement a national reintegration strategy.

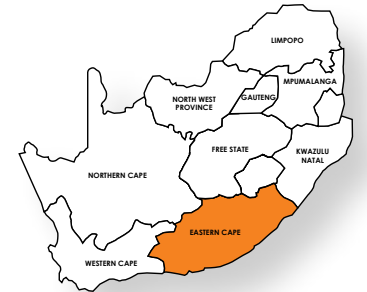

EASTERN CAPE



NICRO Eastern Cape continues to position itself strategically to ensure maximum impact and service delivery excellence. The organisation, which remains the only accredited service provider in its field in the Eastern Cape, has become more visible within the communities it serves and strengthened its crime prevention, diversion and offender rehabilitation services during the year under review. Good stakeholder relations have been maintained and this past year saw an increase in networking activities involving a wide range of stakeholders.

The Department of Safety and Liaison expressed a need for NICRO's increased involvement in community policing forums (CPFs) as well as community crime prevention, in partnership with the police services and schools. An agreement was subsequently reached resulting in NICRO staff members participating in capacitating building initiatives for local CPF members. In East London, a partnership with the Departments of Safety and Liaison and Education is grounded in the safer schools programme. The Department of Correctional Services continues to serve as a key strategic partner in terms of offender rehabilitation and social reintegration.

The Eastern Cape (at 36%), together with KwaZulu-Natal, continues to render the majority of NICRO's offender reintegration services. The majority of these interventions were conducted in East London as a result of the closure of St Albans Correction Facility for renovations in Port Elizabeth.

The Youth Diversion Programme reached 206 youths, the majority of whom participated in the Adolescent Drug Abuse Prevention and Treatment (ADAPT) Programme, the Youth Empowerment Scheme life skills programme and the Beyond Boundaries intervention conducted for school going youth at risk. Many children who commit minor offences seem to be merely cautioned by the police. It also appears that children are committing more serious offences which do not warrant diversion but rather sentencing to a child and youth care centre. These trends have contributed to a decrease in youth diversion referrals from the courts.

Adult diversion services are still the most frequently utilised intervention in the province with the majority of beneficiaries participating in adult life skills, substance abuse and restorative justice programmes.

Highlights and Special Achievements

- Offender reintegration services continue at a pace with 129 beneficiaries participating in the Tough Enough Programme.
- The Safety Ambassadors Programme is operational in five schools at which 110 safety ambassadors completed the two-year programme, graduating in March 2018.

- Our crime prevention initiatives, which target local communities and stakeholders, are proving extremely active and successful and boast a 380% target attainment rate.
- The Clinical Unit commenced service delivery this year. Three training and capacity building programmes were conducted for the Departments of Safety and Liaison and Social Development while clinical services were provided for learners from Port Elizabeth's communities. With increased marketing efforts and staff capacity, this unit has the potential to do very well in the Eastern Cape.
- NICRO Port Elizabeth has secured R 1.6 million in funding from the Department of Social Development to implement a former offender programme commencing in April 2018.
- Some 76 awareness raising initiatives highlighting the dangers and consequences of crime, substance abuse, bullying and gangsterism reached about 16 707 individuals.
- In May 2017 NICRO East London hosted the sixth annual youth debating and public speaking competition, a round robin tournament involving eight schools which is sponsored by the Department of Arts, Sports and Culture. Cambridge High School won the competition which featured current issues such as crime, substance abuse and teenage pregnancy, which are particularly relevant to young people.

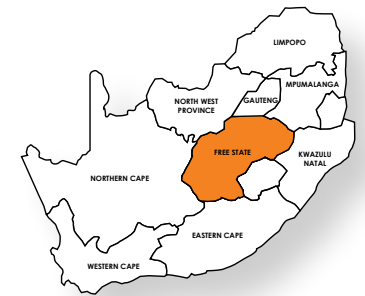

During the reporting period, NICRO Free State's office, located in Bloemfontein, focussed on its diversion services and interventions for youth at risk. Both adult and youth diversion referrals increased as NICRO is still regarded as the preferred service provider in the field of crime prevention.

Highlights and Special Achievements

We are especially proud of our Safety Ambassadors Programme which is operational in three schools in Bloemfontein and continues to go from strength to strength. In partnership with the University of the Free State, a production entitled *The Reality Check*, authored by Prof Nico Luwes, came to life. Safety Ambassadors, who were auditioned and professionally trained, rehearsed at the Scaena Theatre before taking the production to Bloemfontein's schools to create awareness about the consequences of bullying and gender-based violence.

On Heritage Day, our Safety Ambassadors underscored the importance of cultural diversity and promoted unity by hosting a special event involving the preparation and serving of different cultural foods.

The Safety Ambassadors also joined the fight against climate change by planting trees at their schools. The growth of the trees will also serve to symbolise the success and development of the Safety Ambassadors Programme and its efforts to promote a crime-free South Africa.

We eagerly look forward to a new year in which we will embrace the many opportunities that await us. Our focus will be on reaching more school-going youth and assisting them with the acquisition of the skills required to deal effectively with challenges they are likely to encounter.

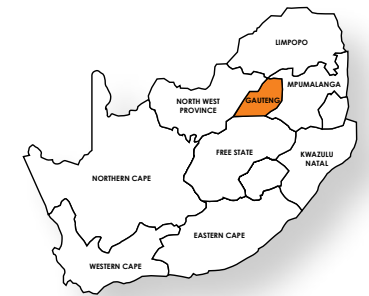

Having cemented good working relationships with all stakeholders in the province, NICRO Gauteng continues to enjoy a sterling reputation for service delivery excellence. Despite a decrease in the number of youth diversion beneficiaries, across the spectrum, early interventions geared towards youth at risk as well as adult diversion services have increased dramatically.

NICRO's social work services remain relevant and popular in the region. The Germiston and Tembisa offices have, for the first time ever, secured programme funding for the Programme for Perpetrators of Intimate Partner Violence from the Department of Social Development. We are enormously grateful for the most welcome grant, which exceeded R 700 000. NICRO Pretoria secured a ground-breaking partnership with the City of Tshwane, resulting in a grant of R 400 000 for a substance abuse project. Special thanks to Nedbank CSI for a R 620 000 grant awarded to the Safety Ambassadors Programme to address substance abuse in five schools in Gauteng, an initiative which has met with enormous success. We are also deeply grateful to the Departments of Social Development and Justice for funding in the amount of R 700 000 for the Road Offences Panel Programme.

Highlights and Special Achievements

- NICRO Gauteng successfully trained 120 social service professionals in the delivery of programmes for perpetrators of intimate partner violence.
- The successful facilitation of consultative research workshops to develop norms and standards for adult diversion.
- Social worker Busisiwe Mzandolo from NICRO Germiston participated in a video series providing insight into the lives and perspectives of people working in interesting professions in South Africa. As a result, NICRO was invited to attend the National Public Service Delivery Improvement Indaba in Durban in May 2017. (The video can be viewed at <https://www.youtube.com/watch?v=yhYn3wNq8bQ>).
- Alida Boshoff, Roseline Motsi and Methuseli Dube contributed to the Voice of The Cape 16 Days of Activism campaign by providing expert knowledge on domestic violence.
- NICRO's Programme for Perpetrators of Intimate Partner Violence was awarded the Gauteng National Service and Excellence Award by the Department of Social Development.

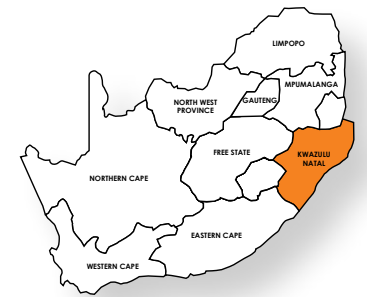

KWAZULU-NATAL



Despite having no area manager, NICRO KwaZulu-Natal, has continued to deliver quality services, exceed all key provincial targets and respond significantly to an increase in antisocial behaviour and substance abuse amongst youth through early intervention, crime prevention and awareness initiatives. We are particularly proud to have rendered services to a larger number of beneficiaries than any other province, especially in terms of our adult diversion and offender reintegration services.

The bulk of the province's work continues to focus on adult diversion with an astounding 7 420 adults having benefitted directly from diversion services, of whom 6 793 attended NICRO's adult life skills programme. Youth diversion still remains somewhat challenging with fewer referrals from the courts. Although youth diversion has been firmly entrenched in the criminal justice process, it appears as if a decrease in the number of children being diverted is mainly due to the fact that fewer children are now entering the child justice system. NICRO KwaZulu-Natal nevertheless diverted 976 young offenders (26% of all NICRO's youth diversion clients) away from the formal criminal justice system.

Highlights and Special Achievements

- In June 2017, NICRO Empangeni visited numerous schools in celebration of Child Protection Week. Staff made use of the opportunity to create awareness of the many types of child abuse which occurs and teach children about their rights and responsibilities.
- NICRO Pietermaritzburg partnered with a range of stakeholders including the Departments of Community Safety and Liaison, Education and Health as well as the South African Police Services and NGOs such as SANCA and Youth for Christ to conduct crime prevention and awareness activities in schools, child and youth care centres and community centres. Some 6 543 beneficiaries were reached as a result of these initiatives.
- NICRO Pietermaritzburg also embarked on a concerted effort to market the organisation, strengthen ties with existing stakeholders and establish new partnerships. From June 2017 to March 2018, this office conducted numerous special presentations and programmes at the Natal Museum, National Botanical Gardens, Northdale Library, Edendale Technical College, Departments of Education and Social Development, and for several other NGOs and the Midlands Social Services Forum.
- The Durban office has established a new partnership with SAB and its Smart Drinking campaign and several joint activities will be conducted in the next year.

Looking Ahead

NICRO Pietermaritzburg will be phasing in a substance abuse programme for adults while the Durban office is planning a number of team building excises to strengthen the team and ensure its continued commitment to service excellence. NICRO Empangeni is exploring the possibility of rolling out the Road Offences Panel Programme (ROPP) to local schools as it believes that a younger audience will benefit substantially from this intervention given that many ROPP beneficiaries are young offenders.

With Grateful Thanks and Appreciation

NICRO KwaZulu-Natal is deeply grateful to its funders for their critical financial support and ensuring that the province was able to achieve its objectives this last year. In this regard, the Department of Social Development deserves special mention, as do our primary stakeholders, the Department of Justice and Constitutional Development and the National Prosecuting Authority.

NICRO KwaZulu-Natal's staff members have earned high praise for their dedication and fine achievements despite staff shortages and having to weather financial

challenges. Special thanks go to the province's two supervisors and the social workers for holding down the fort and to Rozanne Green for supporting the province since the departure of the area manager.

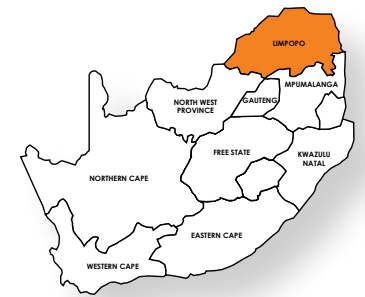

Although our core business involves social crime prevention and offender reintegration, we remain ever mindful that South Africa is home to the world's largest HIV epidemic. Those working to prevent its spread and mitigate its impact increasingly recognise the links between HIV/AIDS, youth and poverty. Thanks to the very special relationship we have with the Limpopo Department of Social Development (DSD), we enjoy a very beneficial partnership with PACT South Africa and Mott Macdonald, ensuring that our clients are well informed about HIV. We again played an important role in assisting with the rollout of the You Only Live Once (YOLO) programme in the Capricorn District. This initiative is geared towards tackling the underlying factors that affect the HIV incidence in the 15 to 24 age group and bringing about behaviour change.

Highlights and Special Achievements

- Adult diversion, which is gaining momentum and becoming increasingly popular, exceeded target significantly.
- A memorable "Breakfast Behind Bars" at the Polokwane Correctional Centre conducted in partnership with the Department of Correctional Services.
- We are proud to report that the number of community members reached far exceeded our expectations thanks to well-executed door-to-door campaigns, educational and awareness initiatives, radio talks, workshops and presentations conducted at schools. These initiatives focused primarily on gender-based violence and substance abuse.
- Our marketing and outreach efforts continue to benefit from the good working relationships we enjoy with the Botlokwa, Moletjie and Turf community radio stations as well as the majority of the stakeholders within the Justice, Social Crime Prevention Cluster.
- Community-based organisations benefitted from a capacity building programme focusing on diversion services that was conducted by NICRO in conjunction with DSD.
- The Safety Ambassadors Programme continues to be very successfully implemented at the OR Mabotja and Mafolofolo High Schools, where learners are working hard at keeping their schools safe.
- The "End It Now" march, which was followed by educational workshops in Sekgosese and Morebeng, drew attention to the plight of women and children and called for an end to the abuse these vulnerable groups continue to suffer.

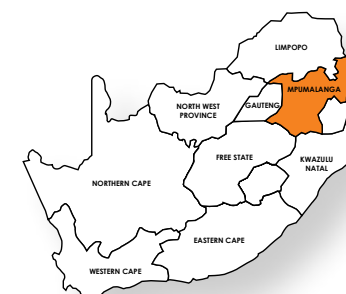

Being a social worker at NICRO is all about caring about your clients. Social workers are the ones who believe that our country and our communities can become better places through enough care and by creating opportunities for our clients to learn to make new and better choices in their lives.

Highlights and Special Achievements

- Despite a financially challenging year, NICRO Nelspruit and Eerstehoek achieved most of the service delivery targets set for the year, in keeping with the business plans submitted to the Mpumalanga Department Social Development.
- NICRO became more visible and accessible as our work increased in our local communities and schools.
- The activities of the Clinical Unit were stepped up significantly and, as a result, we succeeded in increasing income in support of our efforts to expand our operations and contribute towards the sustainability of the organisation.
- NICRO Mpumalanga's diversion intake continues to increase; a fine acknowledgement of the organisation as a premiere diversion service provider.
- The adult substance abuse programme is currently the most frequently utilised programme; an indication that substance related crimes are on the increase.
- NICRO Eerstehoek signed working agreements with the Department of Social Development and a number of community resources such as the Dundonald Home for People with Disabilities, creating opportunities for meaningful community services placements.
- NICRO Nelspruit participated in 46 community outreach events reaching some 6 015 beneficiaries while NICRO Eerstehoek was involved in 34 community outreach events highlighting topics such as domestic violence, social crime prevention, youth and adult substance abuse as well as awareness campaigns pertaining to NICRO's services.
- A total of 3 570 beneficiaries aged 18 years and younger benefitted from primary crime prevention services rendered at 15 local schools.
- Thanks to funding from the Department of Social Development, NICRO Eerstehoek's staff compliment has increased by one staff member from the 2010 team and now includes seven professionals: a social work supervisor, three social workers, two social auxiliary workers and an administrator.

Turning Over a New Leaf

Ms Z was referred to NICRO by a prosecutor in January 2018, following a charge of child abuse. Ms Zulu was assessed and found suitable to attend the Positive Parenting Programme as a non-custodial sentence.

During assessment the offender initially denied intent; she came up with the excuse that she had merely been “playing” with her daughter (the victim) and had unwittingly scotched her with a hot iron. She explained that it was normal practice to play a game in which she would “playfully place an iron on her child” but on the day in question she had not realised that the iron was hot. She added that the child had not cried or showed any signs of physical pain after being scotched repeatedly. NICRO found the offender's version improbable and we were concerned that she would not take responsibility for her actions. At a follow-up interview, the offender finally admitted that she had intentionally scotched her daughter following an argument.

Ms Z attended and successfully completed NICRO's Positive Parenting Programme, which also served to address the risk factors in the mother's life and build or strengthen protective factors - conditions or attributes (skills, strengths, resources, support systems or coping strategies) to deal more effectively with stressful events and mitigate or eliminate future risks.

Ms Z was extremely remorseful of what she had done and was highly motivated and determined to turn over a new leaf. She drew attention to two programme sessions on developing empathy and communication skills, which she found particularly relevant and very useful, and which made a huge difference in her life. She expressed a deep-seated commitment to implementing all she had learned and applying her newfound skills and knowledge to her daily life. She was reunited with her child upon completion of the programme.

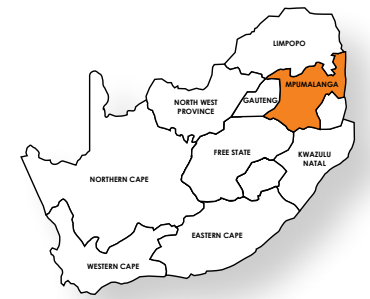

NORTHERN CAPE



The Northern Cape is a vast province with relatively few non-profit organisations serving a small population. As a result, the number of beneficiaries tends to be lower, making the much needed services more expensive than in the more densely populated provinces, but all the more crucial.

Despite funding challenges and staff shortages during the year under review, NICRO Northern Cape nevertheless continued to render quality adult and youth diversion services in addition crime prevention initiatives and interventions for youth at risk.

Keeping Children Safe

NICRO Northern Cape takes a preventative approach to child protection, focusing on minimising risk factors such as anti-social attitudes and behaviour, negative peer pressure and substance abuse that could result in vulnerable children coming into conflict with the law. Our approach is focussed on diverting young offenders away from the formal criminal justice system to keep them safe, changing offending behaviour and offering young people a very real opportunity to turn their lives around, reach their full potential and become contributing members of the community who are an asset rather than a burden or threat.

Restorative Justice for Adult Offenders

NICRO Northern Cape's adult diversion service continues to prove popular and go from strength to strength. By channeling adult offenders away from the courts into diversion programmes designed to ensure behaviour change and the acquisition of critical new skills, they successfully avoid the often brutal consequences of the criminal justice system and being given a criminal record. In this manner, those in conflict with the law remain in the community, continue working and are able to support their families.

All our clients are in receipt of after-care support services and are tracked for 12 months. We believe that, in addition to attending effective and impact programmes, this practice reduces recidivism and ensures that reoffending is kept to a minimum.

WESTERN CAPE



NICRO Western Cape focusses on crime prevention initiatives targeting children and youth as well as diversion services for adults. Crime prevention initiatives take the form of community awareness activities in addition to direct services aimed at young people exhibiting high-risk behaviour and school learners.

The overarching goal of NICRO's crime prevention initiatives is to reduce the risk factors while simultaneously strengthening protective factors, or the resilience of at-risk youth, in order to reduce and prevent anti-social behaviour and victimisation as well as the commission of crime within the school environment and, ultimately, within the community.

Highlights and Special Achievements

- NICRO Western Cape rendered adult diversion services to 2 955 beneficiaries, more than double our target, from eight courts located in Atlantis, Bellville, Bishop Lavis, Blue Downs, Kuilsriver and Wynberg.
- Crime prevention interventions were conducted at four schools in Delft (Rosendaal High, Voorbrug High, Hindle Road Primary and Masonwabe Primary Schools) as well as four schools in Elsies River (Lucinda Primary, St Edwards Primary, Elsies River High and St Andrews High Schools) where the Beyond Boundaries life skills programme was presented to 240 learners in addition to 160 educators and parents.
- In September 2017, the Making of a Criminal: Part 2, a compelling live theatre performance created by Pollsmoor inmates, took place at the Artscape Theatre as part of the See Me: I Am Human Indaba hosted by NICRO, in partnership with the Department of Correctional Services, Vardeteateret and Fredskorpset (the Norwegian Peace Corps). This intimate and courageous production offered thought-provoking insights into the lives of offenders and communities that continue to bear the brunt of South Africa's socio-economic disparities. The performance provided a glimpse into the hidden artistic, musical and poetic talent found in the prisons of the Western Cape through the efforts of NICRO's Help I Am Free theatre rehabilitation project, conducted in collaboration with Vardeteateret and supported by Fredskorpset Norway.
- NICRO's Tough Enough Programme provided support and offender reintegration services to seven of the ten theatre participants as well as eight parolees and other former offenders.
- The "A Second Chance Theatre Project", a new collaborative arts and social justice project undertaken by NICRO in conjunction with the University of Cape Town's Centre for Theatre, Dance and Performance Studies and the Western Cape Government's Department of Correctional Services was initiated. The project uses the medium of arts and theatre as a key tool for the successful rehabilitation and reintegration of inmates.

The Making of a Criminal: Part 2, which follows on the success of last year's production, The Making of a Criminal, was staged at the Artscape Theatre in September 2017. This courageous initiative uses theatre as a powerful healing tool and a rehabilitation strategy to offer inmates a meaningful life after prison and facilitate successful reintegration.

ROAD OFFENCES PANEL PROGRAMME



NICRO's Road Offences Panel Programme (ROPP) was piloted in 2010 to address the challenge of growing numbers of offenders arrested for driving under the influence of alcohol (DUI), speeding and reckless driving and disturbing statistics that indicate that human error is a contributing factor in some 89.5% of motor vehicle accidents.

The NICRO Road Offences Panel Programme focuses on changing the individual's attitude towards alcohol use, driving under the influence and road safety generally and, in so doing, on changing offending behaviour. At the onset of the programme, participants almost always have limited knowledge of road safety and how alcohol affects the individual and his / her abilities. Few participants realise that your driving is impaired, even after one unit of alcohol, and that you may be intoxicated, despite being under the legal limit.

The programme is about bringing conscious and trained behaviour to the fore and ensuring that people realise that all driving behaviours involve making critical decisions. For this reason, drivers need to be alert and aware of their surroundings, themselves and the decisions they take.

Not only has this intervention had a positive influence on reducing drunk driving and keeping South Africans safe on the road; it also impacts positively on the domestic and business lives of its beneficiaries. Participants develop and practice greater responsibility and are more eager to honour their commitments to family and work obligations.

During the year under review ROPP, which constitutes 7% of total service delivery, touched the lives of 10 638 people: 1 773 direct beneficiaries who participated in the programme in addition to 8 865 indirect beneficiaries. The programme is

currently offered in the Eastern Cape, Free State, Gauteng, KwaZulu-Natal, Limpopo, Mpumalanga and the Western Cape.

Road Offences Panel Programme beneficiary testifies to what he has learned by attending the intervention:

"This programme was designed to bring about mitigation. The Road Offences Panel Programme has been put into place to show us the consequences of our actions as well as the responsibilities that we as road users have on the road. To always be weary and alert of the surrounding environment, to adhere to the speed limits on each set of roads, not to drive recklessly and negligently and not to drive under the influence of any controlled substance be it alcohol or any mind impairing drug. There is zero tolerance for the mentioned offences and the result of this is that lives can be taken away, emotional and financial burdens and the subsequent loss of opportunities in the future.

The content of the programme has made me a more careful driver. It has taught me to adhere to every rule of the road, failure to comply with these rules endanger my life and the subsequent lives of everybody around me. I will always be considerate to other road users. I am more aware of how the law works, especially the consequences that follow.

I would like to thank the staff of NICRO for their support in assisting me in this matter and for instilling the correct skills in me".
